

ASSUMPTION OF RISK, WAIVER, LIMITATION OF LIABILITY AND INDEMNIFICATION

I understand that some dogs at a training session or boarding may be difficult to control and may cause injury to Me, my dog, family members, friends and guests even when handled with the greatest degree of care.

In consideration of good and valuable consideration, I HEREBY UNCONDITIONALLY, FULLY AND COMPLETELY RELEASE Got Your Back K9 Life and its trainers, paid or otherwise, employees, officers, members, and all other persons with dogs in attendance at any event or training or boarding held by Got Your Back K9 Life, from any and all liability for any and all injuries or damage I or my dog may incur or suffer, including but not specifically limited to any injury or damage resulting from any action of any dog. I expressly assume all risks of such damage or injury while attending any training, boarding or other function or event of Got Your Back K9 Life, or while on the training or boarding grounds or surrounding areas Used in any manner by Got Your Back K9 Life.

I hereby agree to indemnify and hold harmless Got Your Back K9 Life and its employees (paid or unpaid), officers, members and agents from any and all claims, including claims of family members and friends and guests I bring to any training or boarding function or event. Got Your Back K9 Life hereby reserves the right to exclude, remove or otherwise deny access to any person or dog it deems unsafe or unfit to be in attendance at any training or boarding function or event. I agree to immediately remove my dog from any training or boarding function or event upon the request of any employees (paid or unpaid), officers, members and agents of Got Your Back K9 Life, with or without reason given. I agree to allow Got Your Back K9 Life to use any photo or video likeness of me and that of my dog for promotional purposes and with no expectation or demand for any compensation of any kind. I agree that any photo or video I or my family, friends or guests take shall not be used in any manner without the express written permission of Got Your Back K9 Life and that if written permission is given I shall clearly state the name "Got Your Back K9 Life, Jacksonville, FL" on all such photos or videos.
